PUBLIC FINANCE MANAGEMENT ACT

(No. 18 of 2012)

IN EXERCISE of the powers conferred by sections 6 (2) (j) of the Makueni County Sand Conservation and Utilization Act 2015, the Makueni County Sand Conservation and Utilization Authority makes the following regulations—

THE PUBLIC FINANCE MANAGEMENT (THE MAKUENI COUNTY SAND CONSERVATION AND UTILIZATION (ESTABLISHMENT AND FUNCTIONS OF WARD SAND MANAGEMENT COMMITTEE, REVENUE, SAND RATES AND ADMINISTRATIVE PROCEDURES) REGULATIONS, 2015

PART 1-PRELIMINARY

Citation

1. These regulations may be cited as the Makueni County Sand Conservation and Utilization (Establishment and Functions of Ward Sand Management Committee, Revenue, Sand rates and Administrative Procedures) Regulations, 2015, and shall come into operation on such date as the County Executive Member may, by notice in the County Gazette, appoint.

Interpretation

- 2. In these Regulations, unless the context otherwise requires—
- "Act" means the Makueni County Sand Conservation and Utilization Act, 2015;
- "Authority" means the Makueni County Sand Conservation and Utilization Authority established under the Act;
- "commercial use outside the county" means sand harvested in Makueni County and transported for use outside the county;
- "domestic sand harvesting" means harvesting of sand for domestic household use, which should be transported by use of a cart, wheelbarrow, donkey or any other means not exceeding one ton and should not be stockpiled for commercial purposes;
- "domestic use" means use of sand harvested and transported for home improvement;
- "Executive Committee Member" means the county executive committee member for the time being in-charge of environmental matters in the county;
- "local use" means use of sand harvested and used within the county for internal development and improvement of infrastructure and other local commercial purposes;
- "Sub-County Committee" means the Sub-County Sand Management Committee established under the Act;
- "Ward Committee" means the Ward Sand Management Committee established under regulation 3.

PART II—ESTABLISHMENT AND MANAGEMENT OF THE WARD SAND MANAGEMENT COMMITTEE

Establishment of Ward Sand Management Committee

3. (1) The Authority shall establish a Ward Sand Management Committee in every ward within the county.

- (2) Each Ward Committee shall comprise of -
- (a) Ward Administrator who shall be the chairperson to the Committee;
- (b) one person nominated by the County Commissioner in the respective ward;
- (c) one person representing faith based organizations nominated by the Chief Officer incharge of environment;
- (d) one person representing the youth in the ward nominated by the Executive Committee Member in charge of youth;
- (e) one person representing persons with disability in the ward nominated by the Executive Committee Member in charge of social services;
- (f) one person representing women in the ward nominated by the Executive Committee Member in charge of gender;
- (g) one person representing local NGOs or CBOs affiliated to environmental conservation working within the ward nominated and nominated by Executive Committee Member;
- (h) one person representing the Water Resource Users Association within the ward nominated by the Executive Committee Member;
- (i) one person representing the licensed sand dealers within the ward nominated by the Executive Committee Member;
- (j) one person representing riparian land owners in the ward;
- (k) the Ward Revenue Officer, ex officio; and
- (l) Ward Environmental Officer, ex officio, who shall be the secretary to the Committee.

Functions of the Committee

- The functions of the Ward Committees shall be to—
- (a) advise the Sub-County Committees on sand harvesting sites and transport routes:
- (b) monitor designated sand harvesting sites and report to the Sub-County Committee on those requiring restoration and rehabilitation;
- (c) ensure proper carrying out of all sand related activities in the ward;
- (d) recommend sustainable sand conservation and utilization measures to the Sub-County Committee; and
- (e) any other duties as may be assigned by the Sub-County Committees or the Authority.

Termination and replacement of members of Ward Committees

- 5. (1) The Authority may terminate the appointment of a member of the Ward Committee appointed under regulation 3 (c), (d), (e), (f), (g), (h), (i) and (j) if such a member—
 - (a) is adjudged bankrupt or enters into a composition or scheme of arrangement with his creditors;
 - (b) is convicted of an offence and sentenced to imprisonment for a term of six months or more without the option of a fine;

- (c) is incapacitated by prolonged physical or mental illness from performing his or her duties as a member of the Committee; or
- (d) becomes, for any reason, incapable or incompetent of properly performing the functions of the office.
- (2) Where a member of the Committee dies, resigns or is otherwise removed from office, a replacement shall be made in accordance with these Regulations.

PART III – DUTY TO GIVE INFORMATION, REVENUE AND SAND RATES

Duty to give information

- 6. (1) Where a public officer has reasons to suspect that a vehicle has been used for the unlawful removal of sand, he may require the owner of that vehicle to give him information as to the name, address, description and whereabouts of the person driving the vehicle and any other person travelling in the vehicle at the time of the alleged offence, as well as the place from which the sand has been removed, and the owner of the vehicle shall be obligated to give such information to the best of his knowledge.
- (2) A public officer may require any person to give information in relation to the identification of the driver or passenger of a vehicle suspected of having been used for the unlawful removal of sand, and such a person shall be obligated to give such information to the best of his knowledge.
- (3) Any person who withholds any information required from him or her shall be guilty of an offence punishable under the Act and these Regulations.

Revenue

- 7. (1) The Authority shall raise revenue through -
- (a) license application and registration fees,
- (b) sale of sand,
- (c) fines; and
- (d) any other sources as per the Act.
- (2) The Authority shall open, maintain and operate bank account in Kenya.
- (3) The Authority shall prepare a budget of annual estimates and present it to the Executive Committee Member before the 30th March every financial year.
- (4) The fiscal year of the Authority shall run from 1st July to 30th June of the following year.
- (5) The Authority shall present its audited financial reports for the preceding year to the Executive Committee Member before 31st August.

Sand Rates

- 8. (1) The Authority shall collect—
- (a) KSh. 1,400 per tonne of sand loaded from a designated harvesting site for commercial purposes outside the county from each registeredtransporter; and
- (b) KSh. 100 per tonne of sand loaded from a designated harvesting site for local use within the county from aregistered local sand transporter.
- (2) The rates in sub-regulation (1) shall be subject to review depending on prevailing market forces.

PART IV—ENFORCEMENT, PENALTIES, AND ADMINISTRATIVE PROCEDURES

Enforcement

- 9. (1) The Authority shall have powers to impose penalties for persons who contravene the Act and these Regulations.
- (2) The Authority shall use Wote Central Business District as its administrative center to handle all cases and complaints pertaining to sand harvesting.
- (3) The Authority may mount road blocks to apprehend persons, vehicles, machines and equipment which are involved in illegal sand harvesting and transporting contrary to the Actand these Regulations.
- (4) The Authority shall apprehend any persons and vehicles harvesting and transporting sand in undesignated sites and roads.
 - (5) The Authority shall engage its own enforcement team to ease its duties.

Penalties

- 10. (1) The Authority may initiate civil proceedings to recover enforcement and litigation expenses incurred through the court of law.
- (2) The Authority may withdraw the license of a person who violates these regulations and the guidelines for harvesting and transporting sand.
- (3) The Authority shall enforce instant penalties to persons who have committed offence under the Act and these Regulations.
 - (4) The Authority may use evidence preservation camera.

Administration and delivery of services

- 11. (1) The Authority shall ensure that its services are decentralized to enable efficiency and effectiveness in line with the principles of devolution.
- (2) The Authority shall liaise with other national and county government institutions and offices to ensure effective delivery of services under the Act and these Regulations.

THE PUBLIC FINANCE MANAGEMENT ACT

(No. 18 of 2012)

IN EXERCISE of the powers conferred by sections 12 (2) and 38 of the Makueni County Sand Conservation and Utilization Act 2015, the County Executive Committee Member responsible for environmental matters makes the following regulations:

THE PUBLIC FINANCE MANAGEMENT (MAKUENI COUNTY SAND CONSERVATION AND UTILIZATION (COMPOSITION OF SUB-COUNTY SAND MANAGEMENT COMMITTEE, LICENSE APPLICATION FEES AND FORMS, GUIDELINES AND REHABILITATION) REGULATIONS, 2015

PART 1-PRELIMINARY

Citation

1. These regulations may be cited as the Makueni County Sand Conservation and Utilization (Composition of Sub-County Sand Management Committee, Licence Application Fees and Forms, Guidelines and Rehabilitation) Regulations, 2015, and shall come into operation upon publication in the County Gazette.

Interpretation

2. "Act" means the Makueni County Sand Utilization and Utilization Act, 2015;

"Authority" means the Makueni County Sand Conservation and Utilization Authority established under the Act;

"Executive Committee Member" means the county executive committee member for the time being incharge of environmental matters in the county;

"commercial useoutside the county" means sand harvested in the county and transported for use outside the county;

"domestic sand harvesting" means harvesting of sand for domestic household use, which should be transported by use of a cart, wheelbarrow, donkey or any other means not exceeding one ton and should not be stockpiled for commercial purposes;

"domestic use" means use of sand harvested and transported for home improvement;

"local use" means sand harvested and used within the county for internal development and improvement of infrastructure and other local commercial purposes;

"Ward Committee" means a Ward Sand Management Committee established under the Makueni County Sand Conservation and Utilization (Ward Sand Management Committee) Regulations, 2015;

"Sub-County Committee" means a Sub-County Sand Management Committee established under the Act.

PART II—COMPOSITION OF SUB-COUNTY SAND MANAGEMENT COMMITTEES AND SHARING OF REVENUE

Composition

3. (1) Pursuant to section 12 (2) of the Act, each Sub-County Sand Management Committee shall comprise of -

- (a) Sub-County Administrator, ex officio, who shall be the chairperson to the Committee;
- (b) one person nominated by the County Commissioner in the respective Sub-County;
- (c) one person representing faith based organizations nominated by the Chief Officer in charge of environment;
- (d) one person representing the youth in the Sub-County nominated by the Executive Committee Member in charge of youth;
- (e) one person representing persons with disability in the Sub-County nominated by the Executive Committee Member in charge of social services;
- (f) one person representing women in the Sub-County nominated by the Executive Committee Member in charge of gender;
- (g) one person representing local NGOs or CBOs affiliated to environmental conservation working within the Sub-County nominated by the Executive Committee Member;
- (h) one person representing the Water Resource Users Association within the Sub-County nominated by the Executive Committee Member in charge of environment;
- (i) one person representing licensed sand dealers within the Sub-County nominated by the Executive Committee Member;
- (j) Sub-County Revenue Officer, ex officio;
- (k) one person representing riparian land owners in the sub-County; and
- (l) Sub-County Environmental Officer, ex officio, who shall be the secretary to the Committee.
- (2) The Sub-County Committee may co-opt into the membership of the Committee any person whose knowledge and skills are considered necessary for the effective discharge of the functions of the Committee.

Termination and replacement of members of Sub-County Committees

- 4. (1) The Authority may terminate the appointment of a member of the Sub-County Committee appointed under regulation 3 (c), (d), (e), (f), (g), (h), (i) and (k) if such a member—
 - (a) is adjudged bankrupt or enters into a composition or scheme of arrangement with his creditors;
 - (b) is convicted of an offence and sentenced to imprisonment for a term of six months or more without the option of a fine;
 - (c) is incapacitated by prolonged physical or mental illness from performing his duties as a member of the Committee; or
 - (d) becomes, for any reason, incapable or incompetent of properly performing the functions of office.
- (2) Where a member of the Committee dies, resigns or is otherwise removed from office, a replacement shall be made as per these Regulations.

Sharing of Revenue

- 5. (1) The Authority shall ensure revenue raised from the sale of sand is shared in accordance with section 35 of the Act.
- (2) In the event of any disagreement regarding access, ownership, benefit sharing, or management approaches in sand harvesting, the Executive Committee Member shall consider the complaint and make an appropriate resolution.
- (3) The Authority shall determine the rates to be followed in compensating the sand loaders under this regulation.

PART III—LICENSING FEES, FORMS AND REGISTRATION

Application fee for sand harvesting license

6. Any person applying for sand harvesting license shall pay non-refundable application fee of KSh.3,000 for local commercial use and KSh.10,000 for external commercial use or use outside the County.

Application fee for sand transporting license

7. Any person applying for sand transportation license shall pay a non-refundable application fee of KSh.3,000 for local commercial use and KSh.10,000 for external commercial use or use outside the County.

License application form

8. Any individual, groups of individuals or registered company interested in sand harvesting and transportation shall apply using the format as prescribed in the Schedule by the Authority.

License fee for transporting sand license

 Where the Authority approves an application for license to transport sand for external commercial use the applicant shall pay a license fee of KSh. 10,000 per month or an annual fee of KSh. 100,000.

Compliance Certificate

10. The Authority shall issue a certificate of compliance to individuals and registered companies involved in sand harvesting and sand transportation who have complied with the requirements of environmental management including restoration of the environment.

Registration of sand harvesting loaders

- 11. (1) The Authority shall register persons over 18 years with identification cards as sand loaders.
- (2) Sand loaders to be registered under this regulation should be persons who reside within the particular ward.
- (3) Licensed dealers shall pay the sand loaders in accordance to the rates determined by the Authority.
 - (4) Licensed dealers shall engage only registered sands loaders.

PART IV—SAND HARVESTING AND TRANSPORTATION GUIDELINES AND REHABILITATION

Sand harvesting and transportation Guidelines

- 12. The Sub-County Committees and the Ward Committees shall ensure licensed dealers adhere to the following guidelines—
 - (a) On-farm harvesting-
 - (i) sand harvesting shall not exceed two meters in depth;
 - (ii) designated harvesting sites shall be at least 50 meters away from any river course;
 - (iii) sand harvesting shall be done concurrently with restoration of areas previously harvested sites with the guidance of the Authority;
 - (iv) sand harvesting shall only be done using the open cast method; and
 - (v) there shall be no underground tunneling or extraction of sand;
 - (b) River-bed harvesting-
 - sand harvesting from any riverbed shall not exceed 1-meter depth of the river-bed;
 - (ii) sand harvesting shall not be allowed on river-banks;
 - (iii) sand harvesting shall not be permitted unless restoration has been undertaken on sites previously designated for sand harvesting;
 - (iv) no lorries shall be permitted to enter river-beds to access any sand thereon;
 - (v) loading of sand is to be done from designated harvesting sites along the river course;
 - (vi) no machines shall be used in sand harvesting in the river-bed save for loading 100 meters off shore;
 - (vii) no sand harvesting shall take place within 100 meters of either side of any bridge along any river or stream;
 - (c) Transportation and restoration-
 - (i) any person who undertakes or wishes to transport sand shall possess valid license from the Authority under the Act indicating—
 - (1) the quantity of sand to be transported on a daily basis;
 - (2) the mode of transportation;
 - (3) the place and designated area from which it will be harvested; and
 - (4) the place to which it will be transported to;
 - (ii) sand for domestic use transported on tuk tuks, pick-ups, donkey, and carts and not for piling will not require payment; and
 - (iii) the license shall at all times remain in the vehicle and must be produced to a public officer on demand;
 - (d) Permitted hours for sand harvesting-

Sand harvesting shall take place between the hours of 6am-6pm.

Rehabilitation

- 13. (1) The Authority on the advice of the Sub-County Committees and the Ward Committees shall close a sand harvesting site if the guidelines on harvesting and transportation are violated and if it is depleted and needs rehabilitation.
- (2) The Sub-County Committees and the Ward Committees may source funds for rehabilitation of the closed sites from the Authority.
- (3) The Sub-County Committees and the Ward Committees shall oversee the rehabilitation of sand harvesting sites closed to ensure—
 - (a) that the area is restored to as near as possible to its original status; and
 - (b) ensure that no adverse effects of the sand harvesting activities of the closed sites.
